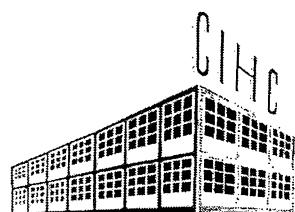

President's Message

As we begin a new season of activity, the CIHC is ready to enter a new and significant phase of development.

It's already been a busy year. We hosted two successful events in the spring: the International Cockshutt Club visit to Brantford on April 4th, and the annual Fourth Pillar Forum on May 22nd. Over the summer, we launched a new website (www.canadianindustrialheritage.com), which I encourage all members to visit and comment on. We were disappointed, however, that we could not get access to 66 Mohawk to begin work on the Industrial Heritage Park. This project will have to wait until soil remediation is complete on the former Mohawk-Greenwich brown-field site.

I'm pleased to announce that we have hired a part-time Office Manager. Ashley Fournier was formerly Operations Manager with the Arts Block and brings experience and expertise in media relations, partnership development, event planning and fund-raising, all areas of prime importance for the CIHC. Ashley started work in September.

The challenge before us now is to find a permanent home. We may have to start with smaller quarters while we raise funds, but we feel it's essential to have a place where at least part of our collection can be exhibited. With that as a starting point, we can hold more events to promote our vision and increase our activity in every respect.

This exciting new phase will be the focus of the 2014 Annual General Meeting. The AGM will be held on Wednesday, November 5th from 7:00 to 9:00 pm at the Brantford Arts Block, located at Unit 21 111 Sherwood Drive in Brantford. We will not have a guest speaker this year. Instead we hope to have an open-ended and wide-ranging discussion about the future of the CIHC. Topics that we want your views on include where you would like to see us established, how our collection can be increased, and how we can raise the necessary funds. You will see the program for the evening elsewhere in this newsletter. Please come and share your thoughts with us. This is a crucial moment for the CIHC and we want to know your views.

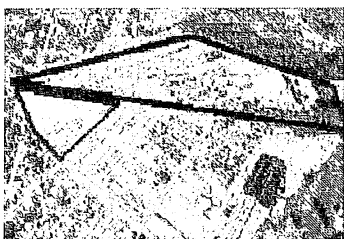
The Products of Greenwich-Mohawk By: Rob Adlam

One of the best kept secrets about the City of Brantford is that during the early part of the 20th century, its industrial prominence ranked it third in Canada, behind Montreal and Toronto, based on the export value of its manufactured goods globally. A major contributor to this phenomenal achievement was the factory district located on the 52 acre site bordered by Greenwich and Mohawk Streets.

To celebrate the exploits of the companies that were once located there, a six-part series will briefly introduce the background of each of these industries, their products and their lasting impact on Canada and the world market.

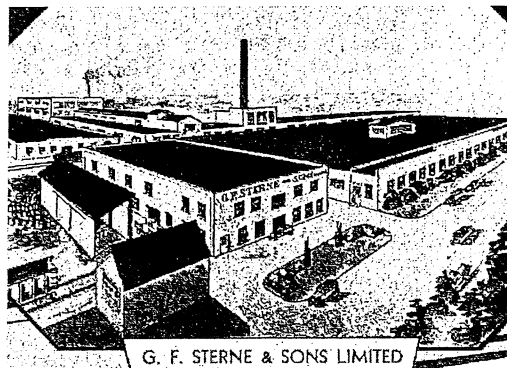
*Sternson Limited
No Mystery... Just Chemistry*

Once located on the smallest of the three parcels of land in the district at 22 Mohawk St. (the area outlined in red below), Sternson Limited was an example of one man's entrepreneurial initiative and the success of a family-owned company.



In 1896 George F. Sterne began experimenting with the manufacture of stove polish and cement to be used in mounting and repairing furnaces. His daytime job was with the Buck Stoveworks, so this sideline was done at night out of his home. The business met with success and would eventually grow to include products for domestic hot water and steam boilers.

By 1906 a factory was built on property purchased on Bruce St., and G.F. Sterne was joined in the business by his sons.



During this period of growth and activity, G.F. Sterne & Sons were supplying products to a large portion of the stove and furnace manufacturers across Canada.

In 1922, the company was incorporated, but still owned by the Sterne family. By 1927, the product line had grown further to include supplies for the building trade such as material to waterproof concrete and surface hardening compounds. Another major specialty was the Fine Chemical line which produced flavourings, essences, extracts and food colours.

A larger production facility was needed to meet the demands of the business and in 1967 Sternson Limited (the name was changed in 1932) moved into a vacant factory complex at 22 Mohawk St. that once produced wagons, truck bodies and semi-trailers.



The business of producing construction products, industrial chemicals and water treatment systems and chemicals continued and in 1979 the Sterne family sold the company to M.T. Bright Holdings Ltd.

The facility closed in 1998 and the factory buildings were torn down. Today it awaits its rebirth as part of the larger brownfield redevelopment planned for the entire site.
